BIRTHDAY GENERAL RULES

1. A \$100 deposit is required to book a party. Payment is due within 7 days of booking a reservation or 7 days before the day of the party, whichever date is earlier. Parties are subject to cancellation for nonpayment of deposit unless prior arrangements are made. The remaining balance is due upon the completion of your birthday party. Only Cash or Credit is accepted for birthday party bills.
2. You will not receive a refund of your deposit if party is cancelled within 14 days of party.
3. Maximum capacity for the indoor aquatic party room is 24 people. An additional room may be available to rent at the time you book your party to accommodate up to 49 people.
4. The basic aquatic package includes 20 admissions to the aquatic center. All party guests need an admission to enter the facility including children and adults- even if a guest does not intend to swim. Children under two are always free to our facility. Additional admissions are \$5 per person.
5. The dance party packages include 10 dance participants. Additional dance participants are \$10 each.
6. Birthday guests only have access to the areas in which the birthday party is located. Ex. If you purchase a pool party, guests must stay in the pool area, they will not have access to the rest of the facility.
7. If the swimming area is closed due to inclement weather or mechanical problems and unable to reopen, we will continue the birthday party and issue a Frisco Athletic Center Swim Pass for each child in the birthday party.
8. **NO OUTSIDE FOOD, DRINKS OR HELIUM BALLOONS ALLOWED DURING INDOOR PARTIES WITH THE EXCEPTION OF BIRTHDAY CAKE AND ICE CREAM.**
9. If you choose to come early to swim, please be aware that your room or pavilion will not be available to your guests until your scheduled party time. Party areas may be available approximately 15 minutes prior to the scheduled party time for decorating.
10. Party areas must be cleared at the scheduled ending time to allow the host to clean and decorate for the next scheduled party.
11. Due to City of Frisco policy, hosts are not allowed to accept tips for their services.

INDOOR AQUATIC AREA GENERAL RULES

1. Have Fun!
2. Adult/guardians must be at least 18 years of age.
3. Adult/guardians of children 6 and younger must be wearing a bathing suit and actively participating in the water with their children at all times. **Ratio is 1 adult per 4 children 6 and under.**
4. Adult/guardians of children ages 7-9 must remain in the Aquatic Area. **Ratio: 1 adult per 10 kids ages 7-10.**
5. All swimmers are required to take a cleansing shower before entering the pool.
6. Properly maintained swimsuits only. No denim, cut-off shorts, spandex, etc.
7. Swim diapers are required for young children. Regular diapers are prohibited in the pool. Swim diapers are available – ask a staff member for assistance.
8. Anyone having open cuts, wounds, etc. is not permitted in the pool.
9. U.S. Coast Guard approved flotation devices only. No water wings, noodles or inner tubes are allowed.
10. Food is prohibited in the pool area including gum and candy. No glass containers.
11. No running, diving, flips or horse play of any kind.
12. No swim toys, snorkels or fins. Masks cannot cover the nose.
13. No animals are allowed in the pool area.
14. Use of cameras and/or video recording devices must have prior approval by management.
15. The City of Frisco is not responsible for lost or stolen items.
16. Contact management for a complete list of pool rules.
17. Staff reserves the right to enforce other rules as necessary to ensure the safety of our members and guests.
