GENERAL CONTEST INFORMATION

- Entry fee is \$12 per entry for residents and \$15 for non-residents. Checks should be made payable to the City of Frisco.
- All entry forms and fees must be returned to the Frisco Athletic Center (5828 Nancy Jane Lane, Frisco, TX 75035) or the Senior Center (6670 Moore St., Frisco, TX 75034).
- Entries are limited. **Registration deadline is Wednesday, November 30.**
- Entries must be delivered to 6255 Frisco Square Boulevard on Thursday, December 1 between 4 p.m. and 7 p.m. All entries should be picked-up on Saturday, December 3 between 9 and 10 p.m. Houses not picked up by this time will become property of the City of Frisco Parks & Recreation Department.
- All entries will be on display at Frisco Square (6255 Frisco Square Boulevard) from 5 p.m. to 9 p.m. on Saturday, December 3 during Merry Main Street.

CONTEST RULES

- Entries and their foundations may not exceed 15 inches in width or length. There is no restriction on height. Foundations must be sturdy for easy transport (cardboard is too flexible - plywood is preferred).
- Children ages 10 and under may have adult assistance in creating and decorating their houses. Children ages 11 and up must construct and decorate their houses without adult assistance. However, parents please assist and supervise all children when using stovetops, ovens, microwaves, etc.
- Entries must be made entirely of edible materials (with the exception of the foundation) and must incorporate the holiday or seasonal theme.
- Entries must be original creations. Store-bought gingerbread houses or gingerbread house kits are not eligible.
- One entry per person/group.
